ESG – What does ESG even mean?

E = environmental

- Measures how the company performs as a steward of the natural environment focusing on:
 - Waste and pollution
 - Greenhouse gas emissions
 - Natural resource depletion
 - Climate change





ESG – What does ESG mean?





S = social

- Looks at how the company treats people and concentrates on:
 - Employee relations
 - Diversity
 - Working conditions
 - Health and Safety



ESG – What does ESG mean?



G = governance

- Examines how the company polices and governs itself and focuses on:
 - How the company manages its risks
 - Corruption and bribery
 - Board diversity and structure
 - Shareholder rights




How do investors sort through the data?

RPM's ESG Rating: BB (AAA is the best)


Sector Ranking: ~42 out of 53 companies

Why are Our Rankings so Low?

- Rankings are based on publicly available information.
- Prior to 2020 RPM had not filed an ESG report and was not disclosing many of its initiatives.
- We are still in the data gathering stage and have yet to set any goals or metrics.
- Some ESG rankings do not include our most recent ESG report as it was filed after the annual cutoff.

What have We Done to Improve Our Rankings?

- Engaged ERM to conduct a materiality assessment and assist in disclosures.
- Published inaugural ESG report in August 2020.
- Created RPM ESG webpage.
- Reduced electrical consumption by 10MM kilo-watt hours from 2018-2019.
- Developed new initiatives around energy efficiency, zero landfill, renewable resource use, greener chemistry, life cycle analysis, LEED support and emission reductions.


Materiality Assessment Process




RPM International Inc. ESG Materiality Assessment

Current & Potential Focus Areas




Prioritized Focus Areas





RPM Materiality Matrix








RPM Materiality Matrix







- Gather data and analyze for calendar 2021 and develop metrics and goals
- Assess Material Topics and Develop Action Plans
- Address Ratings and Rankings Issues
- Pinpoint ESG disclosure gaps
- Improve transparency
- Focus on more defined goals and metrics for monitoring and driving improvement
- Develop public position statements, policies, procedures
- Anti-Harassment, Human Rights, EEO/employer of choice, EHS, anticorruption
- ESG Cross-Functional Committee formed to report to Governance and Nominating Committee of Board of Directors
